BYLAW NO. 521-23

A BYLAW TO ESTABLISH MANDATORY RESIDENTIAL AND COMMERCIAL RECYCLING INITIATIVES AND FEES FOR RECYCLING SERVICES

The Council of the Town of Lafleche, in the Province of Saskatchewan, enacts as follows:

1. RECYCLING SERVICES

- a) Recycling services are mandatory.
- b) A recycling cart with a unique serial number will be provided to each applicable commercial and residential property (as identified in Sections 2 and 3 below) by the Recycling Contractor.
- c) The carts remain the property of the Recycling Contractor and must not be used for any other purpose than recycling or be removed from the assigned property.
- d) If a replacement cart is required, the registered property owner will be responsible for all costs charged by the Recycling Contractor.
- e) The recycling collection schedule is provided by the Recycling Contractor and is available at the Town Office.

2. RESIDENTIAL

- a) Recycling services are mandatory for all residential properties where a utility account is created, regardless of whether the residence is occupied or not.

3. COMMERCIAL

- a) Recycling services are mandatory for all commercial properties where a utility account is created, not including tax exempt properties unless requested by the property owner.
- b) If a cart is not provided by the Recycling Contractor, the commercial property must arrange for recycling services with regularly scheduled pick-ups by a service provider.

4. FEES & ARREARS

- a) The Town of Lafleche shall set monthly recycling service fees, to be paid by the owner of all previously identified commercial and residential properties, as set out in Schedule "A", attached to and forming part of this Bylaw.

- b) Monthly recycling service fees shall be invoiced every second month and included on the utility notices prepared and distributed by the Town in February, April, June, August, October, and December of each year.
- c) Utility notices are due in full within thirty (30) days of the invoice date.
- d) By resolution of council, outstanding utility accounts will be transferred to the property's tax roll.

5. FORCE AND EFFECT

- a) This Bylaw No. 521-23 comes into force and is effective with the June 2023 utility notice billing.
- b) Bylaw No. 482-15 and Bylaw No. 509-19 An Amending Bylaw are hereby repealed.

Read a second time this 13th day of April, 2023.

Read a third time and adopted this 13th day of April, 2023.

Schedule "A" to Bylaw No. 521-23

The following monthly recycling service fees will be invoiced every second month:

1. Residential Recycling Fee - \$18.00 per month per recycling cart.
2. Commercial Recycling Fee - \$18.00 per month per recycling cart.
